JUDGMENT

The issues in the above-entitled action having duly been tried before both a jury and the Hon. Jennifer G. Schecter, a Justice of this Court, at a Term, Part 54, of this Court, held at the courthouse thereof, located at 60 Centre Street, Room 228, New York, NY 10007, from August 19, 2024, through August 26, 2024, and the plaintiffs, Norberto Jorge Levin, having his address at Bulnes No. 2736, 22nd Floor, Apr. 4, Buenos Aires, Argentina, and Fondo De Inversion Privado Levin Global (“Fondo”), having its address at Guardia Vieja 181, Office 405, Providencia District, Santiago, Región Metropolitana de Santiago, Chile, having appeared by their attorneys, Schlam Stone & Dolan LLP, and the defendants, Carlos Luis Salvini, having his address at Rua Antônio das Chagas 828, Apt. 1905, São Paulo, Brazil and Mauricio Valentim Gugliano, having his address at Rua da Paz 1674, São Paulo, Brazil, having appeared by their attorneys, Fox Horan & Camerini LLP, and the issues having been duly tried, and the Jury and the Court having after due deliberation, respectively, duly reached a verdict and filed a decision in writing on August 28, 2024;

NOW, on the joint motion of Plaintiffs and Defendants, it is

ORDERED and ADJUDGED that Plaintiffs' first cause of action, for breach of contract against Defendants Carlos Luis Salvini and Mauricio Valentim Gugliano, is dismissed; and it is further

ORDERED and ADJUDGED that Plaintiffs' second cause of action, for declaratory judgment against Defendants Carlos Luis Salvini and Mauricio Valentim Gugliano, is dismissed; and it is further

ORDERED and ADJUDGED that Defendant Carlos Luis Salvini have judgment and recover from Plaintiffs Norberto Jorge Levin and Fondo de Inversion Privado Levin Global, jointly and severally, the sum of \$18,000; plus interest at the statutory rate of 9% from December 31, 2016, which interest until entry of this judgment equals \$ 13,066.52, amounting in all


X to the sum of \$ 31,066.52; and that Carlos Luis Salvini have execution therefor; and it is further

ORDERED and ADJUDGED that Defendant Mauricio Valentim Gugliano have judgment and recover from Plaintiffs Norberto Jorge Levin and Fondo de Inversion Privado Levin Global, jointly and severally, the sum of \$3,601; plus interest at the statutory rate of 9% on in the sum of \$2,613.30 \$3,600 from December 31, 2016, and interest at the statutory rate of 9% on \$1 from August 1, 2015, which interest as of the date of the entry of this judgment equals \$ 0.85,


X amounting in all to the sum of \$ 6,215.15; and that Mauricio Valentim Gugliano have execution therefor; and it is further

ORDERED and ADJUDGED that Defendant Carlos Luis Salvini's counterclaim, for breach of contract as against Plaintiff Norberto Jorge Levin, is dismissed; and it is further

ORDERED and ADJUDGED that Defendant Mauricio Valentim Gugliano’s counterclaim, for breach of contract as against Plaintiff Norberto Jorge Levin, is sustained with an award of nominal damages.
