This PARTNERSHIP AGREEMENT is made on this 5th day of November, 2012 between MD GIAS UDDIN, DOB: 02/25/1981 (NY Driver License: 712872848, SSN: ***-**-9995), residing at 377 Ocean Pkwy, Apt 5A, Brooklyn, NY 11218 and MOHAMMAD JAHANGIR ALAM, DOB: 03/05/1970 (NY Driver License: 420557639, SSN: ***-**-6096), residing at 3103 91st Street, Fl 1, East Elmhurst, NY 11369.

1. **BUSINESS.** The parties hereby form a partnership under the corporation BHAT AND CHOWDHURY INC. (EIN. 46-1336343).
2. **TERM:** The partnership shall begin on Nov. 5th, 2012 and shall continue until terminated as herein provided.
3. **PERCENTAGE/SHARE.** Md Gias Uddin (President), owns 50.00% of the total 100% partnership; Mohammad Jahangir Alam (General Partner), owns 50.00% of the total 100% partnership.
4. **PROFIT AND LOSS.** The net income/loss of the partnership shall be divided and borne proportionally between partners based on their ownership. If a partner has no credit balance in his income account, losses shall be charged to his capital account.
5. **SALARIES AND DRAWINGS.** Neither partner shall receive any salary for services rendered to the partnership.

6. **INTEREST.** No interest shall be paid on the initial contributions to the capital of the partnership or on any subsequent contributions of capital.

7. **MANAGEMENT DUTIES AND RESTRICTIONS.** The partners shall have proportional rights in the management of the partnership business.

8. **TERMINATION.** The partnership may be dissolved at any time by agreement of both the partners, in which event the partners shall proceed with reasonable promptness to liquidate the business of the partnership. The partnership name shall be sold with the other assets of the business.

9. **ARBITRATION.** Any controversy or claim arising out of or relating to this agreement, or the breach hereof, shall be settled by arbitration in accordance with arbitration laws of the State of New York.

10. **SURVIVAL CLAUSE.** General survival laws and New York State's applicable law will apply in case of death or incapability of either partner.

11. **TAXATION.** It is agreed among the partners that the liability for the taxes will be born equally between the partners.


