N.Y. Pattern Jury Instruction-Civil 4:2 Contracts Quasi Contract Restitution Unjust Enrichment

As you have heard, Plaintiff David Aronov claims that the managing members were unjustly enriched at David Aronov's expense in that the Operating Managers have been guilty of illegal, fraudulent and oppressive actions towards the shareholders, the property and assets of the Company are being looted, wasted, or diverted for non-corporate purposes by managing partners, thereby enriching themselves at the expense of the minority shareholders and continuing the corporation's existence for the sole purpose of benefiting. The managing members deny Plaintiff's claims and contend that they acted in good faith, exercised sound business judgment and did not Breach their Fiduciary Duty.

Unjust enrichment occurs when one person has obtained money from another person under such circumstances that, in fairness and good conscience, the money should not be retained. In those circumstances, the law requires that person to repay, return to or compensate the other person.

Plaintiff has the burden of proving that funds were misused by members if the subject LLC and profits were misdirected to non-members of the subject LLC. If you decide that managing members did not misappropriate funds, you will find for Defendants.
