JEFFREY WASSERMAN, being duly sworn, deposes and says:

- I am the majority owner and managing member of plaintiff JG Club Holdings,
   LLC ("JG Club"). As such, I am fully familiar with the facts stated in this affidavit.
- 2. I respectfully submit this affidavit in support of the motion by GRKS II, LLC ("GRKS II") and DZ Ventures, LLC ("DZ Ventures") for the dissolution and appointment of a receiver of Plaintiff Jacaranda Club, LLC ("Jacaranda").
- 2. GRKS II and DZ Ventures each own a minority membership interest in plaintiff

  JG Club, which in turn owns a 48.9% ownership interest in Jacaranda. Jacaranda's only business
  is, in turn, the operation of the club, restaurant and bar known as "Sapphire New York," located
  at 333 East 60<sup>th</sup> Street, New York, New York (hereinafter, "Sapphire").
- 3. Specifically, I submit this affidavit to confirm that I discussed in detail with Jack Constantine and Francis Moezinia GRKS II's and DZ Ventures' belief that an application should be made for the dissolution and appointment of a receiver of Jacaranda. I explained to them that

I did not intend to bring such applications on behalf of JG Club, and invited GRKS II and DZ Ventures to seek such relief if they consider the same to be appropriate.

6. Accordingly, GRKS II's and DZ Ventures' application on behalf of JG Club for the dissolution and appointment of a receiver of Jacaranda has been made with my consent and approval. Since I have expressly agreed that GRKS II and DZ Ventures may seek on behalf of JG Club the dissolution and appointment of a receiver of Jacaranda, Defendants should not be heard to complain that GRKS II and DZ Ventures are so acting on behalf of JG Club.
